The EU-ML-4X WiFi floor heating extension module is designed to operate with the EU-L-4X WiFi controller.

It allows for an extension of the floor heating system through the addition of 4 zones via the use of either wireless sensors and controllers, or the wired RS-485 (TECH SBUS) controllers connected to/registered with the EU-L-4X WiFi controller. It employs thermoelectric actuators, e.g. STT-230/2 T, STT-230/2 M.




Connection of the EU-ML-4X WiFi module with the EU-L-4X WiFi controller
